### **Income Eligibility Criteria:**

Our program is committed to serving families that meet the income eligibility criteria defined by the Federal Poverty Guidelines (FPG). To determine eligibility, families must submit proof of income, including the most recent tax returns, W-2 forms, pay stubs, or other official documents verifying their household income. This process ensures that our services are provided to those most in need and who meet the specific income thresholds outlined in the FPG.

### **Special Eligibility Provisions:**

In our commitment to inclusivity and equitable access to education, our program extends eligibility to certain groups regardless of their family's income status:

1. Students Experiencing Homelessness: Our program adopts a barrier-free approach for homeless students. Understanding the instability and challenges faced by these families, we ensure that students experiencing homelessness are eligible for our program to support their educational journey and provide stability in a time of uncertainty.
